

## Keno Grazing Suit Court Decisions

<b>Purpose of Court Filing</b>	<b>Date Filed</b>	<b>Summary</b>
Preliminary Injunction Granted	4/2/2013	Granted preliminary injunction against grazing or tethering livestock on greenbelt
Court decision on 1st contempt case	6/28/2013	Keno found guilty and sentenced to \$1000 fine and 7 days in jail
Court decision on 2nd contempt case	11/13/2013	Found that Keno "violated the Preliminary Injunction" and set date of 1/10/2014 for sentencing. Court ordered that ASMD could request payment of fees and costs by Keno.
Order and Declaratory Judgement - Permanent Injunction	12/20/2013	<ol style="list-style-type: none"><li>1. Court issued Declaratory judgement which "protects ASMD from wilfull trespass onto the Greenbelt despite the fact that the greenbelt is unenclosed by a lawful fence."</li><li>2. Keno is permanently enjoined from causing or allowing any animal that he owns or controls to wander outside of his own property or property for which he has valid, written prior permission for such use, and to graze the Greenbelt."</li></ol>
Sentencing on 2nd contempt case	2/6/2014	<ol style="list-style-type: none"><li>1. Court ordered that Keno pay ASMD attorney fees of \$4193.50 and court costs of \$435.07.</li><li>2. Court ordered that Keno pay fine of \$1000 and additional 7 day jail sentence.</li><li>3. Court stayed fine &amp; jail sentence for 3 months from date of January 10 hearing.</li></ol>
Court Order Granting Stay & Setting Bond	2/19/2014	Court ordered Stay of Enforcement of Injunction pending \$1000 Bond which was posted by Keno's attorney pending appeal of case to Colorado Court of Appeals
Judgement Affirmed	7/16/2015	<ol style="list-style-type: none"><li>1. Colorado Appeals Court confirms the Order and Declaratory Judgement of 12/20/2013</li><li>2. Colorado Appeals Court confirms the \$1000 fine and 7 day jail sentence but denies the award of fees and costs to the District as this award would not remediate damages caused and was therefore ineligible for remedial sanctions.</li><li>3. Court denied Keno's request for payment of fees and costs.</li></ol>
Denial of Rehearing by Appeals Court	8/6/2015	Colorado Court of Appeals denied Keno's request for a rehearing.
Petition for Hearing by Colorado Supreme Court	9/2/2015	Request by Keno for hearing by the Colorado Supreme Court. We anticipate that the Court will take up to seven months to decide whether they will hear the case. Generally, the Court only accepts about 1% of cases for review.
Announcement by Colorado Supreme Court	3/14/2016	The Colorado State Supreme Court announced that they declined to hear arguments regarding Keno v. Aspen Springs Metropolitan District. This marks the end of Mr. Keno's appeal.
